**Gift Aid** - The Gift Aid scheme allows us to reclaim from the Inland Revenue an **extra 25p for every pound** you give to us. **To be eligible for gift aid**, the income tax and/or capital gains tax you pay must be equal to or greater than the tax reclaimed by CoI on your subscription in the tax year it is paid (25p per pound paid). For example, if you're paying the basic £18 fee, you'll be eligible for gift aid if your income tax is equal to or greater than £4.50 this year. You can cancel this option at any time by notifying us. If you pay tax at the higher rate you can claim further relief in your self-assessment tax return.
